**PRIVACY POLICY** NW Natural's privacy policy is posted on its website at nwnatural.com.

## Explanation of common billing terms:

**BILLING FACTOR** Converts metered units of gas into therms.

**LATE PAYMENT CHARGE** A charge may be applied to past-due utility billings.

**PAYMENT DUE DATE** Bills are due when rendered and become delinquent if not paid by the due date printed on the bill.

**THERMS** A measure of energy. One therm equals 100,000 BTUs (British Thermal Units). To determine the number of therms used, multiply the Units of Gas by the Billing Factor.

**UNITS OF GAS** Gas meters record the volume (units) of gas you use. To calculate the units of gas used, subtract the previous meter readings from the present meter reading.

## WARM (Weather Adjusted Rate Mechanism)

Default billing method that helps ensure NW Natural does not collect more or less than its fixed costs from its Oregon customers, regardless of fluctuations in weather.
